## REPORT ON 2023 MEMBERSHIP SURVEY

DR. TRACEY DERWING

You will recognize Dr. Tracey Derwing from the 2023 Fall Conference agenda where she gave a talk on Accent Myths and Realities and introduced us to the Speech Accent Archive. When she went looking for published research relevant to shorthand reporters' experience with accented speech, she found very little, which led her to survey our membership to determine how ASRA members are dealing with several issues and our opinions on the role Al may take over the next few years. Thirty-eight reporters participated in the survey, some of whom Dr. Derwing later interviewed; she also arranged an interview with a lawyer to better understand the stakes and the answers she was given.

Dr. Derwing now returns for the 2025 Fall Conference to share her report and findings with us from the first study of its kind on our specific industry. She will take us through some of the reported job challenges; technology challenges; the Al "threat"; the most rewarding aspects of the job; and finally, the advice that members would give newcomers to the field. She will then take us through her conclusions and recommendations going forward.

Tracey Derwing is a Professor Emeritus from the University of Alberta's Teaching English as a Second Language program in the Faculty of Education, and an adjunct professor of Linguistics in the Department of Linguistics at Simon Fraser University. Her research interests include improved communication on the part of L2 learners and their interlocutors (especially with regard to pronunciation), immigrant and refugee settlement issues, and citizenship education.

Among other things, she has investigated native speakers' speech modifications for second language speakers, and interventions to enhance native speakers' comprehension of second language accented speech. Tracey currently serves on a committee advising the Canadian government on federally-funded language training programs for newcomers. She has published widely (11 books and over 100 articles), has coorganized several Pronunciation in Second Language Learning and Teaching conferences, and serves on the Editorial Boards of several journals.
